The Legacy Giving program encourages and recognizes Hennepin members and friends who sustain and nourish the church's future through estate planning. A Legacy Gift is a commitment beyond annual stewardship and capital pledges. Legacy Gifts are invested to provide financial support in perpetuity for program and building funds. These gifts also may provide significant financial planning benefits for donors and their families.

Our gifts reflect our faith, beliefs and values. A Legacy Gift helps to ensure for future generations what you treasure about the church — what has inspired you, deepened your faith and nurtured your family and friendships. Your gift to Hennepin Church and/or the Hennepin Foundation, regardless of size, can be a precious legacy.

WAYS TO MAKE A LEGACY GIFT

Any gift is meaningful. We welcome the opportunity to recognize you for including Hennepin Church/Foundation in your estate plan. In planned giving, your decisions and arrangements are made currently, but the receipt of the gifts by the church is usually deferred. Some examples are noted below; detailed rules apply to each type of gift.

BEQUESTS BY WILL OR TRUST

A will or revocable living trust may provide for a bequest of a percentage, or a specific amount or asset, or the remainder of your estate after specific bequests to heirs and beneficiaries.

LIFE INCOME GIFTS

Charitable gift annuities and charitable remainder trusts can provide income for life for you or a person you designate, with the remainder benefiting charity.

IRAS AND RETIREMENT BENEFIT PLANS

Gifts from IRAs and retirement plans through beneficiary designations may provide important tax savings to your estate and heirs.

LIFE INSURANCE

A paid-up life insurance policy, or a new policy listing Hennepin as beneficiary and owner, may be contributed. Any on-going premium payments for policies owned by Hennepin are considered tax-deductible contributions.

LIFE ESTATE GIFTS

With the donor retaining use of the property for one or more lives, a remainder interest in a principal residence, farm or vacation property (such as a cabin) is provided for the church.
